CALL TO ORDER: President Hopkins called the public hearing to order at 6:00 p.m. for the Proposed Property Tax Increase: Truth in Taxation Hearing.

ROLL CALL: President Heidi Hopkins; Vice President Peggy Deyne; Treasurer Joe Olsen; Secretary Peggy Bucaro; Dave Barry, Monica Boyer, and John Sias, Trustees.

ACTION: President Hopkins stated the purpose of the Public Hearing as: The proposed property tax increase Truth in Taxation hearing; notice of proposed property tax increase for the Bartlett Public Library District.

1. A public hearing to approve the proposed property tax levy increase for the Bartlett Public Library District for 2022, 2022 to 2023 fiscal year, will be held on Monday, October 17, 2022 at 6:00 p.m. at the Library, 800 South Bartlett Road, Bartlett, Illinois.

President Hopkins stated as follows: Any person desiring to appear at the public hearing to present testimony to the Library District may contact Heidi Hopkins, Board President, 800 South Bartlett Road, Bartlett, Illinois, 630-837-2855. President Hopkins did not receive any inquiries from a person who wished to speak at the Public Hearing.

The corporate and special purpose property taxes extended or abated for 2021 were \$3,332,660.00, which includes the estimated Cook County extension. The proposed corporate and special purpose property taxes to be levied for 2022 are \$3,874,489.00. This represents a 16.3% increase over the previous year's extension.

The property taxes extended for debt service and the public building commission leases for 2021 were zero dollars.

The estimated property taxes to be levied for debt service of public building commission leases for 2021 are zero dollars. This represents a no change over the previous year extension.

The total property taxes extended or abated for 2021 were \$3,332,660.00; the Cook County portion is estimated. The estimated total property taxes to be levied for 2022 are \$3,874,489.00. This represents a 16.3% increase over the previous year extension.
