## BARTLETT PUBLIC LIBRARY DISTRICT COMMITTEE OF THE WHOLE BOARD FINAL MEETING MINUTES

CALL TO ORDER: The meeting was called to order at 6:00 p.m. by President Hopkins.

1. Building Tour

Director Nance and Facility Manager Larry Siegel gave the Board of Trustees a tour of the building. Director Nance highlighted the kitchen off of the meeting room and future plans about reutilizing the space for storage. We also showed the Board the storage closets off of the meeting room and pointed out the locations of the parking lot timers and the electrical disconnect panels.

The Board next viewed the electrical and janitor closets located on the first floor. The old wiring for the Ice Melt Controls needs to be removed from the electrical closet.

Facility Manager Larry Siegel then showed the Board the following items located in the Janitor Closet:

Water Heater for Upstairs

Control Panel for Security System

2-time clocks for parking lot lights

Old fire panel no longer working-new one is downstairs

Director Nance then pointed out the staff conference room, staff washroom and records retention room. A long-term goal is to move the majority of the records to a digital format.

In the Admin area, it was discussed that the HVAC control for the admin offices and staff lounge are located in the Director's Office causing some temperature concerns. There is a current recommendation on the Capital Needs Assessment to repair this issue by converting the system to a Variable/Volume Temperature System.

Punch Clock

Outside Light Time Clock

The Board also toured the Adult Services Department. Facility Manager showed the Trustees the Magazine/Newspaper Storage Room. It was again mentioned about moving the newspapers to a digital format.
