 TAX LEVY ORDINANCE 2025-8**

AN ORDINANCE LEVYING TAXES FOR CORPORATE PURPOSES FOR THE FISCAL YEAR BEGINNING JULY 1, 2025, AND ENDING JUNE 30, 2026, FOR THE BARTLETT PUBLIC LIBRARY DISTRICT, DUPAGE AND COOK COUNTIES, ILLINOIS.

BE IT ORDAINED BY THE BOARD OF LIBRARY TRUSTEES OF THE BARTLETT PUBLIC LIBRARY DISTRICT:

Section 1: That a tax for the following sums of money, or as much thereof as may be authorized by law, to defray all expenses and liabilities of the Bartlett Public Library District be and the same is hereby levied for the purposes specified against all taxable property in the Bartlett Public Library District for the fiscal year commencing on the 1st day of July, 2025 and ending on the 30th day of June, 2026.




